Your vertical wall coating system contains TEX•COTE® COOLWALL® with KYNAR® IR Finish. This warranty takes effect on the Date of Application of the product to your home. If the product fails as described above, Textured Coatings of America, Inc. will replace the product.

This warranty only covers product applied to a single-family residence where the product has been applied in accordance with our specifications. Non single-family residences are excluded from this warranty. E.g. New construction, apartments, condominiums, multi-family dwellings, and commercial use.

Notice: Your home is protected with the TEX•COTE® COOLWALL® with KYNAR® Infrared Heat Reflective coating system. It is a scientific formula tested by the Department of Energy. You should not cover up this finish with ordinary paint. If you want to change the color or repaint you home, you should use a TEX•COTE® COOLWALL® finish coat that may be obtained by contacting your TEX•COTE® representative, by emailing [info@textcote.com](mailto:info@textcote.com), or by calling Textured Coatings of America, Inc.'s National Customer Service Department at 1-800-454-0340.

This warranty is transferable one (1) time, if transferred to a purchaser of your home within five (5) years after the Date of Application of the product to your home. In order for the warranty to be transferred, a written notice must be sent to Textured Coatings of America, Inc. within thirty (30) days of the sale of your home. To confirm that the warranty transfer has been processed by Textured Coatings of America, Inc., we will send a new warranty out to the purchaser of the home. In all other instances, the warranty is extended only to the original purchaser of the product.

For breach of warranty as a result of a defect in product, product replacement is our only responsibility and your only remedy. Textured Coatings of America, Inc. shall have no responsibility to apply the replacement product or to pay for or contribute to the cost of labor for such application.

This warranty does not cover damage resulting from the settling of the building, major building movement, cracking, water intrusion from the roof, leaks from windows or caulk joint, acts of God (E.g. wind storms, hail, flood, hurricane, tornado, earthquake), or mechanical or external physical causes. This product warranty excludes the application of any TEX•COTE® product over masonite or any other wood-fiber composite hardboard siding. This warranty also does not cover the portions of the product applied to fascia boards, entry, exit, and garage doors, trim, and/or any movable surfaces.

We make no other express warranties to consumers. The terms of this warranty are not subject to modification. The sales representative and/or contractor is not an agent or employee of Textured Coatings of America, Inc. and any additional promises or guarantees made by the sales representative and/or contractor shall not become part of this limited warranty.
